The Wish November Sweepstakes (“Sweepstakes”) is sponsored by Contextlogic Inc. (“Sponsor”), One Sansome Street, 40th Floor, San Francisco, CA 94104, USA, and is administered by Prize Logic, LLC (“Administrator”), Two Towne Square, Suite 200, Southfield, MI 48076, USA.

- **SWEEPSTAKES TIMING:** The Sweepstakes begins on November 15, 2022 at 12:00 AM Pacific Time (“PT”) and ends on November 28, 2022 at 11:59:59 PM PT (“Sweepstakes Period”). The Sweepstakes includes fourteen (14) daily entry periods (“Entry Period”) as set forth in the chart below:

Non-winning entries will not carry forward into subsequent Entry Periods. The Administrator’s computer is the Sweepstakes’ official clock.

- **Eligibility:** The Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. Use of the Wish app is governed by the Wish Terms of Use at <https://www.wish.com/en-terms>. Winning a prize is contingent upon fulfilling all requirements set forth herein. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned.

- **HOW TO ENTER THE SWEEPSTAKES:** There are two ways to enter:
 - Purchase Method of Entry: During the Sweepstakes Period, an eligible entrant may download the Wish app and create an account (if he/she doesn't already have an account). Then, entrant may make a purchase on the Wish app. For every \$1 spent, an entrant will receive one (1) entry into the applicable Entry Period. Purchases that are cancelled or refunded will not generate entries or those entries will be voided by Sponsor. Maximum of four hundred (400) entries per Entry Period.
 - Free Method of Entry: During the Sweepstakes Period, an eligible entrant may visit <https://cs-help.wish.com/hc/en-us/articles/9840326730903> ("Website") and enter his/her email address. If it is the entrant's first visit to the Website, then he/she must complete and submit the registration form by providing the information requested by Sponsor including, but not limited to: complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP Code, daytime phone number, date of birth, and agree to these Official Rules. Upon subsequent visits, entrant will only need to enter his/her email address. After submitting the required information, entrant will automatically receive one hundred (100) entries each time the form is submitted. The form may be submitted four (4) times per Entry Period for a maximum of four hundred (400) entries per Entry Period.

Limit: Regardless of the method of entry, an entrant may receive a maximum of four hundred (400) entries per Entry Period. An entrant will receive no more than the stated number of entries during the Sweepstakes Period. If more than the stated number of entries is received from the same person, Wish account, or email address on any given day during the Sweepstakes Period, the entries may, at the Sponsor's sole discretion, be disqualified.

IMPORTANT: If you participate via your wireless phone, message and data rates may apply. Please consult your wireless-service provider regarding its message and data pricing plans.

- **RANDOM DRAWING:** On or about the dates set forth in Section 1, Administrator will select one (1) potential winner from among all eligible entries received during each Entry Period. Each winner is deemed to be a potential winner, pending verification of the entrant's eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, at their sole and absolute discretion.
- **PrizeS, approximate retail value ("ARV"), and odds of winning:**
 - **Prizes (14 total, 1 per Entry Period):** Each prize is \$12,000 (each a "Prize"). No more than fourteen (14) Prizes will be available in the Sweepstakes. The ARV of each Prize is \$12,000.
 - **Total ARV:** The total ARV of all Prizes available in this Sweepstakes is \$168,000.
 - **Odds of Winning:** The odds of winning a Prize depend on the number of eligible entries received during each Entry Period.
 - **General:** There is a limit of one (1) Prize per person/household/Wish account during the entire Sweepstakes Period. In no event will more than fourteen (14) Prizes, be awarded. - **how to claim A prize:** Each potential winner will be notified via email by Sponsor or its authorized designee at the email address provided at the time of entry and/or associated with his/her Wish account. Before being declared the winner, each potential winner will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment (“Affidavit”), sent with the email notification. The potential winners must return a fully executed and notarized Affidavit/Declaration to the Sponsor or its authorized designee within three (3) business days from the date it is postmarked as being sent to the potential winner or the Prize may (in Sponsor’s sole discretion) be forfeited. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
